

About Community Kickstart Grant

The ISPT Community Kickstart Grants Program provides financial funding and support to enable community groups to continue their great, important work in our local area.

At the heart of our community, our centre understands the vital role that community groups play in improving the lives of individuals and families. This grant program aims to amplify their efforts by providing financial support to help sustain and expand their projects and services that positively impact and generate outcomes benefiting our local community.

Eligibility Criteria

Who is eligible to apply?

The Community Grant program is open to:

- All registered not-for-profit organisations that provide benefit to the community.
- Local community groups and voluntary organisations. Organisations not based within
 the local community must be able to demonstrate a benefit to members who live in
 the local community.
- Only organisations/community groups that hold an Australian Business Number (ABN).
- Organisations/community groups that do not hold an ABN can engage an auspice
 organisation that meets the definition of a not-for-profit organisation or an
 incorporated association, or provide a service or activity primarily considered the
 responsibility of the State or Federal Government whereby the initiative is outside of
 their core business.

What activities are eligible to apply?

Only community activities that occur within the municipality where the shopping centre you are applying through is located are eligible. Additionally, the activities must be completed before 30 November 2026.

When do applications open and close?

Applications will be taken from 9:00am on Monday 18 August 2025 and must be submitted by 11:59pm AEDT on or before Sunday 21 September 2025, and they cannot be submitted after midnight AEDT on Sunday 21 September 2025.

How are successful grant recipients chosen?

A judging panel will review all applications against the judging criteria and the three highest scoring groups will advance to the community voting. The group which receives the highest number of community votes will be awarded as the 2025 grant recipient.

How to apply

Applicants for the Community Kickstart Grant must register in <u>Good Grants</u>, which requires an email address and password.

A general organisation email and password will enable more than one person to access applications and outcomes. All notification emails and updates regarding the application will be sent to the email address provided in the application.

All applicants must provide the following information when applying for the Community Kickstart Grant:

- Proof of organisation address.
- Financial Records such as an Annual Report that includes financial statements.
- Current Certificate of Public Liability Insurance with \$20 million coverage.

These documents can be uploaded onto the Good Grants platform.

Good Grants will send confirmation of receipt of submitted applications to the email address provided in the application.

Judging criteria

Applications will be assessed on the beliefs outlined by ISPT below. It is essential that all beliefs are covered in the application form. Any supporting materials are welcome and can be uploaded on Good Grants.

What the program cannot fund?

Community Kickstart Grant will not fund the following:

- Applications for individual pursuits.
- Operational costs and core business costs of the organisation e.g. rent or accommodation costs, ongoing fees, mobile phones, bills and insurance fees.
- Employment of staff and their salary or wages.
- Capital expenditure (land, buildings, construction works, refurbishment, renovations, playground installation, landscaping, etc.)
- Venue hire, rent, lease or other costs associated with accommodation.
- Activities that take place outside of the centre trade area.
- Funding for competitions, trophies, prizes or awards.
- Reimbursement of personal expenses, including but not limited to, transport, food/beverage, and accommodation.
- Applications for the singular purpose of promoting political, religious, or spiritual
 activities (this does not include community celebrations of annual calendar religious
 festivals).
- A program, service, or activity that is primarily considered the responsibility of the State or Federal Government and is part of their core business, such as the main activity of schools, hospitals, or other services.

Acquittal of Grant

All grant recipients must complete an acquittal form on or before 30/11/2026. A form will be issued to the successful grant recipient. Incomplete or non-submitted acquittal forms will result in an organisation being ineligible for future grant applications.
